**Patent Acquisition and Collaborative Research and
Technology Development (PACE)**

Call for Proposals for financial support - Fourth Batch

The Department of Scientific & Industrial Research (DSIR) invites proposals from **REGISTERED INDIAN COMPANIES/FIRMS/SMEs** etc under the PACE Scheme for funding development and demonstration of innovative product/ process technologies, traversing the journey from proof-of-concept or laboratory stage to pilot stage, ready to be launched for commercialization. UNIQUE FEATURES OF PACE:

- Development and Demonstration of Technology by industry (either alone or in collaboration with R&D organization/ academic institution/ university in India or abroad.
- Loan to Indian industry and grant to Indian (foreign excluded) R&D organization/ academic institution/ university. Grant will be concurrent with loan and it shall not exceed the amount sanctioned as loan.
- The scheme shall support proposals in any industrial sector* leading to industrially useful applications.
- The scheme shall support proposals which give evidence of existence of proof-of-concept and aim at fulfilling an unmet need.

* Except for proposals purely in the area of Bio-technology , which may be submitted to Department of Bio-technology

ELIGIBILITY:

- Company should be registered in India under the relevant act or hold SSI/MSME registration which is at least 3 years old and profit making.
- Atleast 51% of the shares of the company should be held by Indian Citizens, including NRIs.
- Industry should have IP ownership, acquired or developed by it (patented or un-patented), that will be used for value addition or up-scaling in the proposed project.
- Industry should preferably have a DSIR recognized in-house R&D unit.
- Industry must be in a position to provide evidence that it shall be able to raise its share of funds in the project.
- Collaborating partner, if applicable, should be Indian public funded research institution, implying that one of the criterion should be that at least 50% of the recurring expenses of the institution should be met by the government.

GUIDELINES FOR SUBMISSION OF APPLICATIONS
