

IT Hardware & Electronics: Industry, Process & Benchmarking Country Selection

IT Hardware and Electronics sector include Communication & Broadcasting Equipment, Consumer Electronics, Industrial Electronics, Computer hardware and Electronic Components.

Segments selected for benchmarking under IT Hardware & Electronics Sector includes **Communication & Broadcasting Equipment and Electronic Components.** Communication and Broadcasting Equipment showed the highest exports CAGR of 95% among all the segments. Electronic Components contributed maximum i.e. 37.5% to India's IT Hardware and Electronic sector exports of US\$ 5.4 billion in 2010 followed by Communication & Broadcasting Equipment at 30.1%.

Countries selected for benchmarking include **China and Mexico** for Communication and Broadcasting Equipment. China has a very high share in world segment exports(31%) whereas Mexico scores highly in percentage share in country's sectors' exports (70%) and shows high growth in exports over the last 5 years.

In Electronic Components, countries selected for benchmarking are **China**, **Singapore and Taiwan**. All these countries rank very high in Electronic Components contribution to their total sector exports as well as their contribution to world exports.
