Above Description for C2.2 on Page 6 of Annexure V, shall be read as

***Lumpsum one time cost for Four years software Maintenance and Support Services (MSS) (inclusive of both onsite & helpdesk and token based support for revision / change requests after completion of warranty)***

- 3.** If our proposal is accepted, we will obtain a Security Deposit/Performance Bank Guarantee in the format given in the bid document issued by a scheduled bank in India, acceptable to DSIR, for a sum equivalent to **10%** of the respective bid prices as quoted in our commercial proposal for the due performance of the contract.

Above Para 4 on Page 1 of Annexure IV, shall be read as

***If our proposal is accepted, we will obtain a Security Deposit/Performance Bank Guarantee in the format given in the bid document issued by a scheduled bank in India, acceptable to DSIR, for a sum equivalent to 20% of the respective bid prices as quoted in our commercial proposal for the due performance of the contract.***

4. ₹ 10 Lakhs (Rupees ten lakhs) as EMD amount should be in the form of DD/Bankers cheque/Bank guarantee attached to the Technical Bid. The EMD should be drawn in the name of **DDO, DSIR** payable at **New Delhi**.

Above Para on Page 26 of Bid Document, shall be read as

**₹ 10 Lakhs (Rupees ten lakhs) as EMD amount for both RFPs or ₹ 5 Lakhs (Rupees five lakhs) as EMD amount for each RFP, should be in the form of Demand Draft/ Bankers cheque/Bank guarantee drawn on any Scheduled/Nationalized Bank attached to the Technical Bid. The EMD should be drawn in the name of DDO, DSIR payable at New Delhi.**

5. The tender document must be accompanied by Earnest Money Deposit (EMD) of ₹ 10 Lakhs (Rupees ten lakhs only) in the form of a Demand Draft drawn on any Scheduled/Nationalized Bank in favour of the DDO, DSIR payable at New Delhi.

Above Para on Page 56 of Bid Document, shall be read as

**The tender document must be accompanied by Earnest Money Deposit (EMD) of ₹ 10 Lakhs (Rupees ten lakhs only) for both RFPs or ₹ 5 Lakhs (Rupees five lakhs) for each RFP in the form of Demand Draft/Bankers cheque/Bank guarantee drawn on any Scheduled/Nationalized Bank attached to the Technical Bid. The EMD should be drawn in the name of DDO, DSIR payable at New Delhi.**

6. C2.1 on Page 6 of Annexure V shall also include all the software required for development / deployment of the ERP in DSIR. These software(s) shall be procured in conformity to specifications and costs referred in DGS&D Rate Contract mentioning the RC Number, Date and Validity. **The Software, Media, Additional License and Service Agreement, etc will be the property of DSIR and the same are to be transferred to DSIR.**
7. C2.5 on Page 6 of Annexure V specifying Hardware and System Software in respect of RFP1 and RFP2 is detailed in the table below along with detailed specifications. The Hardware and System Software shall be procured in conformity to DGS&D Rate Contract mentioning the RC Number, Date and Validity. **The Hardware along with System Software and other Software, Media, Service Agreement, etc will be the property of DSIR and the same are to be transferred to DSIR.**
