The appellant (Shri Madanjit Kumar) was available via video conference call. DSIR was represented by Mr. B.N. Sarkar, Sc-G & Incharge (CEL & NRDC matters) & Dr. Anoop Singh, Scientist-D (respondent) and Mr. Vimal Kumar Varun, CPIO were present during the appeal.

2. The appellate authority noted that the appellant was not satisfied with the reply & documentary evidence provided to him by the department against his RTI application No. DOSIR/R/E/21/00023 dated 18.05.2021. Therefore, the appellant in his appeal registration No. DOSIR/A/E/21/00004 dated 11.06.2021 has asked for clarifications and further documentary evidence as sought by him in his RTI application No. DOSIR/R/E/21/00023 dated 18.05.2021.

3. The appellate authority could speak to appellant via video conference call. Appellate authority perused RTI application and noted that the appellant has sought copy of note sheet in his RTI application. As per appellant incomplete information has been provided, only note sheet has been provided but enclosures which has been shown as F/ABCDEF etc. has not been provided.

4. Appellate Authority informed appellant that the information as sought in Point 1-2 in the RTI appeal pertains to Central Electronics Limited (CEL) and this RTI application is already transferred online to CEL by CPIO on 23rd May, 2021.

5. Appellate Authority further discussed the information as sought in Point 4-5 of the RTI appeal, appellant has sought copy of note sheet in his RTI application.

6. Appellate authority after further discussion/deliberation gave a decision that the CPIO/DSIR to provide copy of the note sheet with enclosures shown F/ABCDEF etc. in the note sheet as per the RTI Act as sought in the RTI application to appellant within 15 days with no cost to the appellant. The above appeal stands disposed off.
