The appellant (Shri Madanjit Kumar) was available via video conference call. DSIR was represented by Mr. B.N. Sarkar, Sc-G & Incharge (CEL matters) & Dr. Anoop Singh, Scientist-D (respondent) and Mr. Vimal Kumar Varun, CPIO were present during the appeal.

2. The appellate authority noted that the appellant was not satisfied with the reply provided to him by the department against his RTI application No. DOSIR/R/E/21/00069 dated 10.12.2021. Therefore, the appellant in his appeal registration No. DOSIR/A/E/22/00001 dated 10.01.2022 has asked for information as sought by him in his RTI application No. DOSIR/R/E/21/00069 dated 10.12.2021.

3. The appellate authority could speak to appellant via video conference call. Appellate authority perused RTI application and noted that the appellant has sought desired information as in his RTI application. As per appellant no information has been provided.

4 Appellate Authority discussed the information as sought in RTI appeal. During the discussion respondent informed they have received information from DIPAM. Appellate authority after further discussion/deliberation gave a decision that the CPIO/DSIR requested to send the RTI Appeal question's reply pointwise, to provide information as sought in the RTI application to appellant. The above appeal stands disposed off.

Please provide copy of supporting documents/note-sheet of the department.	
4	Please provide the name of the agency (i.e. either Union of India, DSIR or the successful bidder who will buy the Central Electronics Ltd) will be responsible for the liabilities present and future due to outcome of the legal matters	
5	Please provide the name of the agency (i.e. either Union of India, DSIR or the successful bidder who will buy the Central Electronics Ltd) will pay arrears of employees which us due from 2007	
6	Existing employees of Central Electronics Ltd will have job in Central Electronics Ltd., if yes, please provide the tenure.



The undersigned is directed to refer to DSIR's email dated 24.01.2022 on the above-mentioned subject and to state that Government of India on 29.11.2021 has approved the highest price bid of M/s Nandal Finance and Leasing Pvt Ltd for sale of 100% equity shareholding of GoI in Central Electronics Ltd. However, post identification of successful bidder, representations have been received from CEL Employees Association including payment of past arrears and gratuity of CEL employees post privatization, bidders being inter-related and pending appeal in NCLAT. These issues are under examination. The Letter of Intent (LoI) to the successful bidder has not been issued yet and Share Purchase Agreement containing terms and conditions of strategic sale has not been signed.
