<u>Subject:</u> Issuance of DSIR Registration certificate in respect of In-house R&D unit(s) of Industries and Scientific and Industrial Research Organizations (SIROs) recognized by DSIR with Revised validity up to 30.09.2024 - reg

DSIR is issuing 'Certificate of Registration' to Research Institutions other than Hospital viz., In-house R&D Units (RDI) of Industry and Scientific and Industrial Research Organizations (SIROs) up to 31.03.2024 as per MoF Notification No. 334/03/2023-TRU dt 1.02.2023 wherein standalone notifications were extended up to 31.03.2024 for the purpose of undertaking review during the year.

- 2. Reference is now invited to the Gazette Notification No. 07/2024-Customs dt 29.01.2024, regarding extension of the validity of exemptions lapsing on 31.03.2024 up to 30.09.2024 (copy enclosed), wherein Notification No. 51/96-Customs, dated the 23rd July, 1996, published vide number G.S.R. 303(E), dated the 23rd July, 1996 is being extended beyond 31.03.2024 up to 30.09.2024.
- 3. In view of the above, it has been decided to extend the validity of Registration up to **30.09.2024** for all existing recognized In-house R&D Units (RDI) of Industries and Scientific and Industrial Research Organizations (SIROs) having valid recognition during the period and who's Registration Certificate is lapsing on 31.03.2024.
- 4. However, renewal of recognition of In-house R&D units of Industries and SIROs shall be processed by the department as per the existing guidelines and procedures duly laid down in DSIR.
